Qualified Abatement Services, Inc. (QAS) did submit a bid for the abatement work for the MDPS 2021 Bond Election work and the Bond Team has subsequently negotiated a proposed contract based on that letter. The Bond Team recommends awarding an Abatement contract to QAS on a basis of a lump sum sixty-five thousand dollars (\$65,000.00).

The recommendation of QAS is based on the following items:

- NOVA Environmental, Inc., the District's Environmental Consultant, has submitted a letter to the District dated 12.08.22 which recommends QAS's selection.
- QAS has submitted a letter of Understanding to the District that confirms their intent and ability to complete the work.
- They were the lowest qualified bidder in a public bid process for construction-related services.

Accordingly, the Bond Team recommends that MDPS enter into an agreement with QAS pending final negotiations of terms by the district legal counsel.
